Due to the commencement of repair work on the left span of the floodgate on the Łączany-Skawina Canal on June 27, the left span will be closed to navigation until further notice and navigation will be carried out on the right span.

From January 30, 2023, the lock in Przewóz is closed until the failure is repaired.

From 1 January 2023, entities performing the activities referred to in art. 306 sec. 1 of the Water Law Act, fees for the use of inland waterways and their sections are restored, and from water facilities owned by the State Treasury located on inland surface waters.

State Water Holding "Polish Waters", Regional Water Management Board in Kraków, informs that from 14 June 2022, the shipping lane on the Vistula River from 61+200 km (Tyniec) to 79+150 km is marked in accordance with Art. 5.02 of the Regulation of the Minister of Infrastructure of 28 April 2003 on navigation regulations on inland waterways (Dz.U. /Journal of Laws/ of 2003, No. 212, item 2027) and complies with the requirements governing the rules of night navigation.

Details in notice to skippers No.13/2022

From May 17, 2022 on the section of the Vistula River from km 223+600 - 223+700, due to the low flow in the river and periodic activation of the damming of the Polaniec Power Plant, located at km 223+650 of the Vistula River, there may be difficulties in navigation.

State Water Holding "Polish Waters", Regional Water Management Board in Kraków, informs that due to the ongoing repair works on the Kościuszko barrage, from 9 May 2022 until further notice, the following sluicing hours will be introduced on working days from Monday to Thursday between 7:00 a.m. and 6:00 p.m. and on Friday between 7:00 a.m. and 3:00 p.m.: upstream: 8:00 a.m., 11:15 a.m., 2:00 p.m., 4:00 p.m., 6:00 p.m., downstream: 9:00 a.m., 1:00 p.m., 3:30 p.m., 5:30 p.m.

Details in notice to skippers No. 5/2022

The shipping route on the section from km 0+600 to km 295+200 of the Vistula River, is open to navigation with the limitation of its parameters indicated in the annexes: difficulties 1, difficulties 2, difficulties 3, difficulties 5, difficulties 6.

^{*}Note: the class IV waterway under construction (damming at the Dwory and Smolice steps is 1.0 m lower than the target).
