Pursuant to Art. 14 sec. 1(4) of the Act of July 20, 2017 - Water Law (i.e. Journal of Laws of 2022, item 2625 as amended) and Art. 43 sec. 6 of the Act of December 21, 2000 on inland navigation (i.e. Journal of Laws of 2022, item 1097) State Water Holding Polish Waters Regional Water Management Board in Kraków would like to inform that on July 1, 2023 from 10.30 a.m. to 2.30 p.m. on the section of the Vistula River from km 73+500 to km 74+670 (Zwierzyniecki road bridge in Kraków) a canoeing event will be held entitled "The 5th Championships of the Lesser Poland Region in classic canoeing" organised by the Lesser Poland Canoe Association (on the basis of permission from the Director of the Branch Office in Kraków of the Office of Inland Navigation in Wrocław, ref. no.: NZKR.602.6.2023.RS of June 15, 2023) **The shipping lane on the Vistula River from km 73+500 to km 74+670 on July 1, 2023 from 10.30 a.m. to 2.30 p.m. will be partially closed to shipping traffic at a distance of no more than 50m from the left bank of the Vistula River, so that a free shipping lane is left by the right bank.**
