

## NOTICE TO SKIPPERS No. 1/2023

Pursuant to Art. 14 sec. 1(4) of the Act of 20 July 2017 – Water Law (consolidated text Dz.U. /Journal of Laws/ of 2021, item 2233 as amended) and Art. 43 sec. 6 of the Act of 21 December 2000 on inland navigation (consolidated text Dz.U. /Journal of Laws/ of 2022, item 1097) "Polish Waters" State Water Holding, Regional Water Management Board in Kraków, informs that according to Art.3 sec. 6 of the Act of 17 November 2021 (consolidated text Dz.U. /Journal of Laws/ of 2021, item 2368) on amending the Act on specific solutions related to prevention, counteraction and eradication of COVID-19, other infectious diseases and crisis situations caused by them, amending Art. 568b of the said Act of 2 March 2020, from 1 January 2023, entities performing the activities referred to in art. 306 sec. 1 of the Water Law Act, fees for the use of inland waterways and their sections are restored, and from water facilities owned by the State Treasury located on inland surface waters.

Pursuant to Article 306 (1) of the Water Law Act, charges for the use of inland waterways are considered the charges incurred for:

- 1. transport of persons on passenger and cruise ships;
- 2. transport of goods on cargo ships;
- 3. navigation of empty cargo ships;
- 4. towing or floating of timber;
- 5. use of locks or inclined planes,
